- This statement has been prepared in accordance with Indian Accounting Standard (Ind AS) as prescribed under section 133 of the Companies Act, 2013 read with relevant rules thereunder and in terms of regulations of the SEBI (Listing Obligations and Disclosure Requirements), Regulations, 2015 (as amended).
- Other Comprehensive Income includes net movement of re-measurement of defined benefit plans and alike adjustments.
- The Discloser of statement of Assets and Liabilities and statement of Cash Flow as per Regulation 33(3) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 are an integral part of these results.
- Exceptional items for the year represents irrecoverable debit balances of Rs. 13.86 Lakh. This statement has been prepared in accordance with Ind AS-109.
- Previous year figures have been regrouped / reclassified, wherever considered necessary to conform to the current Period presentations.
- The figures for the last quarter are the balancing figures between the audited figures in respect of the full financial year up to March 31, 2023 and the unaudited published year-to-date figures up to December 31, 2022, being the date of the end of the third quarter of the financial year which were subject to limited review by the statutory auditors.
- As the Company has one Operating Segment and disclosure under Ind AS 108-Operating Segment is not applicable.
- The management has considered the possible impact of disruption caused by restriction imposed to contain COVID-19 spread, on the Company, including of assessment of liquidity and going concern assumption and carrying value of assets, as at 31<sup>st</sup> March 2021. Based on such assumption, it has concluded that none of the assets are likely to be impaired. The company will continue to monitor the future economic conditions and its consequent impact on the business operations, given the nature of the pandemic.
